- II. A few general updates (5 min):
  - DVCA Auction Results *Boosters raised over \$25,000 and more parents/guardians attended than previous year.*
  - Enrollment numbers & new courses enrollment is up across both campuses based upon applications, particularly at JH. Members are curious to know percentage of out-of-district accepted compared to in-district accepted. At this point, in 7<sup>th</sup> grade it looks like a decrease from approximately 45% out-of-district to about 11% for 2018-19. Percentage at HS site remains static at around 25%.

Grad requirements. Groups decides there are several components that need to be removed, including CAHSEE exam and API score. Group's key discussion point is that it would be an important improvement for Da Vinci to create a senior project that is completed over three years based upon the Graduate Profile. Students could work with staff and/or community members during DV career to plan and implement and would then "defend" project results against the outcomes listed on Graduate Profile. Members, including DV admin, raise concerns that this could be a barrier to graduation or to enrollment. Discussion proceeds identifying that perhaps the culmination is highly differentiated with a fairly low threshold for "passing." DV Admin intends to bring idea to staff for consideration.

- ii. LCFF Dashboard Metrics (Tyler): What data trends stand out as strengths? What data trends stand out as weaknesses? What are reasonable and attainable goals? Are there other local metrics that we should include? *Elaine Talley, Kyra Parker and Grace Allen work with Principal Millsap to review LCFF Dashboard Metrics.* Significant time spent on explanation of how to read and make meaning of data. Group identifies the following key findings: increase in suspension rates from previous year; continued excellent graduation results; static performance on ELA test; decrease in performance on mathematics test.
